

Visitor Rules & Regulations

InterEvent – beurzen – organisatie - advies

InterEvent Beurzen B.V. – april 2025

By purchasing a ticket or attending a trade fair or event organized by InterEvent Beurzen B.V. (operating under the name InterEvent exhibitions – organization – consulting), visitors agree to the following Visitor Rules & Regulations.

1. General

Visitors enter the event and participate at their own risk. Parents and guardians are fully responsible for the behaviour of minors. All instructions given by InterEvent staff must be followed at all times. InterEvent reserves the right to remove any visitor who violates these rules or causes (or threatens to cause) disruption, without refund or compensation.

Commercial activities, such as trading or marketing, are not allowed on or near the event premises unless explicitly authorized in writing by InterEvent.

2. Admission

Entry to the event is only permitted with a valid ticket or official invitation. InterEvent may deny access to anyone who is under the influence of alcohol or drugs or who poses a threat to safety or order.

3. Tickets

- Tickets are non-refundable, non-exchangeable, and not extendable.
- Barcodes must remain intact and undamaged; a damaged barcode may prevent entry.
- Tickets may not be copied, resold, or transferred.
- Each ticket grants entry to one person unless otherwise stated.
- Venue details, event dates, and opening hours are stated on the ticket.

4. Prohibited Items

- Weapons or dangerous items (as determined by InterEvent staff) are not allowed.
- The use of illegal substances is prohibited.
- Loudspeakers, radios, or similar equipment are not permitted.
- Bicycles, scooters, skates, and other personal transport devices are not allowed inside, except for wheelchairs and mobility aids.
- Pets are not allowed, except certified service animals.

5. Smoking

Smoking is prohibited indoors. Smoking is only allowed in designated outdoor areas.

6. Safety & Emergencies

- Visitors must not enter technical areas or rooms marked "staff only."
- In case of an emergency (fire, evacuation, severe weather, etc.), all visitors must follow the instructions of InterEvent staff and emergency personnel immediately.

7. Photography & Filming

7.1 Visitors may take photos for personal use after consulting with the exhibitor. Flash and tripods are not allowed. Any commercial or editorial use of photos or recordings requires prior written permission from InterEvent.

7.2 Visitors may be photographed or filmed during the event. InterEvent reserves the right to use this material for promotional and communication purposes across all media. By attending, visitors explicitly agree to this use. For more information, see our privacy statement at www.interevent.org.

8. Children & Supervision

Children up to and including the age of 18 must be accompanied by an adult unless otherwise stated by InterEvent.

9. Tickets, Changes & Promotions

Tickets can be purchased online or at the entrance on the day of the event. Unused tickets will not be refunded. Future promotions or discounts do not entitle earlier buyers to a refund.

10. Late Arrival or No-Show

If a visitor or group fails to attend or arrives late, no refund will be given. Tickets cannot be exchanged or returned. The right of withdrawal does not apply.

11. Damage & Incidents

If you notice damage or an unsafe situation, please report it immediately to a staff member. If you accidentally cause damage, please notify staff before leaving the venue.

12. Liability

Any incident or damage must be reported before leaving the event. InterEvent is only liable for direct damages caused by gross negligence or intent, and only up to the amount paid out by its insurance provider. InterEvent is not liable for indirect or consequential damages, such as lost profits, missed opportunities, or lost items, including those left in cloakrooms or storage areas.

13. Event Changes or Cancellation

InterEvent may reschedule or cancel an event. Tickets remain valid for the new date. If you cannot attend on the new date, you will receive a refund of the ticket price, excluding service and admin fees. If the event is canceled entirely, the ticket price (minus fees) will be refunded via your original payment method.

14. Applicable Law & Jurisdiction

Dutch law applies. Any disputes will be submitted to the competent court of the Midden-Nederland district.

15. Changes to these Terms

InterEvent may update these rules at any time. Updates take effect at the announced date.

16. Final Provision

In addition to these rules, the general terms and conditions of the venue and InterEvent's exhibitor terms also apply. These are available at www.interevent.org. If any part of these rules is found invalid or unenforceable, the rest will remain in full force.
